

QKLG 2024 familiarisation and planning

Self-paced learning package: Guidance

Purpose

The QKLG 2024 familiarisation and planning self-paced learning package is designed to support early childhood professionals and deepen their understanding of the *Queensland Kindergarten Learning Guideline 2024* (QKLG).

Background

In December 2022, state and territory education ministers endorsed the Early Years Learning Framework (EYLF) V2.0 with the changes coming into effect from 1 February 2024.

The QCAA completed a review of the QKLG 2018 in 2024 to align with the EYLF V2.0.

The QKLG 2024 will be implemented by services in 2025.

About the package

The self-paced learning package consists of three modules which contain resources that are designed to familiarise early childhood professionals in the kindergarten sector with the QKLG 2024.

These resources can support planning by showing the alignment between teaching, learning, and assessing using the QKLG 2024.

This package supports early childhood professionals to understand:

- the revisions and updates of the QKLG 2024
- key changes for planning for teaching and learning
- the support and resources available from the QCAA to assist services when planning for implementation of the QKLG 2024.

- From the top toolbar, select **View > Normal**.
- At the bottom-right of the screen, click on the **Notes** icon.

The slideshow and notes work in conjunction with the workbook.

Steps

1. Read through the PowerPoint slides and notes sections. The slides will direct you to the QKLG 2024 and your activity book as you work through them.

2. Complete modules. While you may complete a module of interest, the modules are designed as a package and work best if accessed in order.
3. Engage in professional discussions with colleagues to consolidate learning and discuss opportunities the QKLG 2024 brings to your service.
4. Use the QCAA website to access further resources to extend on your understandings of the QKLG 2024.
