# External assessment invigilators: registrations of interest

# **Purpose**

To notify schools that the QCAA is seeking registrations of interest from Queensland community members for paid Year 12 external assessment invigilator positions.

# **Background**

The QCAA appoints members of the Queensland community to observe and report on the administration of Year 12 assessments throughout the state, from October to mid-November.

Invigilators play an important role in promoting public confidence in the Queensland Certificate of Education (QCE) system and ensuring that proper and fair administrative procedures are implemented.

The invigilator role is independent. They are paid to undertake training and for the external assessment sessions they observe and report on.

## Information

Registrations of interest are now open for community members who wish to become an invigilator. Prospective applicants who register their interest will be notified when invigilator applications open in Term 2 (early June).

Past external assessment invigilators who wish to reapply are also encouraged to register their interest in advance.

#### Invigilators must:

- be at least 18 years of age
- be eligible to work in Australia
- have photographic identification
- · have a valid email address
- have access to a computer, the internet and a printer
- supply names and contact details of two referees
- hold a paid blue card or an exemption card or, if you are a teacher, a current Queensland College of Teachers registration.

### **Principals**

Promote invigilator positions within your school community and encourage suitable people to register their interest now.
