## Consultation on the draft revised Queensland kindergarten learning guideline (QKLG)

### Purpose

To invite kindergarten teachers and service providers to provide feedback on the draft revised QKLG (version March 2024).

### Background

All Australian, state and territory Education Ministers have approved the updated national learning framework *Belonging, Being & Becoming: The Early Years Learning Framework for Australia v2.0* (EYLF V2.0).

The QKLG 2018 is currently being revised to:

- align with the EYLF V2.0
- cater for three-year-olds accessing early education and care in kindergarten.
