# NAPLAN 2025 — access arrangements and reasonable adjustments (AARA) for students with disability

## Purpose

To inform schools of key dates for NAPLAN AARA applications for 2025 NAPLAN testing.

## Background

In 2025, NAPLAN will be held from **Wednesday 12 March to Monday 24 March**.

All eligible students in Years 3, 5, 7 and 9 are expected to participate in the NAPLAN tests.

Under the Disability Standards for Education 2005 (Cth), schools consult with students and/or parents/carers about AARA and implement approved AARA to enable students with disability to access and participate in the tests on the same basis as students without disability.

NAPLAN demonstration tests are available on the [NAP Public demonstration site](#).

The *Record of adjustment for disability (school use only) form* is available in the NAPLAN administration app (Forms & resources tab) and the NAPLAN AARA app (Home tab). This form is to be signed by both the parent/carer and principal as a record of consultation regarding AARA for the 2025 NAPLAN tests. The school retains the original completed form and provides a copy to the parent/carer. A copy is not submitted to the QCAA.

The NAPLAN AARA app is available in the QCAA Portal, to support schools to apply for NAPLAN AARA requiring QCAA approval.

## Key dates

Schools are encouraged to begin consultation with students and parents/carers about NAPLAN AARA in Term 4, 2024.

Due dates for applications for QCAA-approved NAPLAN AARA are shown in the table below.

- In **Term 4, 2024**, submit applications for alternative format test materials. (The QCAA will work with schools requiring alternative formats for Year 7 students and other new enrolments, in Term 1, 2025. Submit applications as soon as possible after enrolment.)
- In **Term 1, 2025**, submit applications for all other QCAA-approved NAPLAN AARA.

<ul style="list-style-type: none"><li>• Assistive technology that requires an unsecured browser</li><li>• Colour contrast modification that requires an unsecured browser</li><li>• Computer template for writing (Year 3)</li><li>• Extra time — double the total test time</li><li>• Scribe (writing test only)</li></ul>	11 February 2025 Submit applications in Term 1, 2025

Other adjustments are approved at the school level, by the principal or principal's delegate prior to test sessions. School-approved AARA are **not** recorded in the NAPLAN AARA app.

School-approved NAPLAN AARA	May be approved
<ul style="list-style-type: none"><li>• Extra time</li><li>• Rest breaks</li><li>• Oral/signed support</li><li>• NAPLAN support person</li><li>• Assistive technology that does not require an unsecured browser and is compatible with the test construct, e.g. ergonomic mouse</li><li>• Alternative items (audio) or (visual)</li><li>• Alternative colour themes</li></ul>	Up to the start of a test session

## What you need to do

Consult with students and parents/carers about NAPLAN AARA. Download the *Record of adjustment for disability (school use only) form* to assist in this process.

Use the NAPLAN [Public demonstration site](#) to determine whether accessibility features built into the platform (e.g. the zoom tool) and/or school approved adjustments can enable students with disability to access the tests on the same basis as other students. Refer to the [National protocols for test administration](#) to manage school-approved NAPLAN AARA.

If QCAA-approved NAPLAN AARA are required, submit applications to the QCAA via the NAPLAN AARA app by due dates.
