P-10 Planning app: In-app messages

Welcome to this P-10 planning app instructional video.

The P–10 Planning app is a free online tool to support Queensland teachers to plan curriculum and assessment using the Australian Curriculum Version 9.0.

This video will identify the messages presented in the planning app.

In-app messages

Information for users is presented in a number of ways in the app depending on the message being presented.

Instructional text

Blue instructional text provides information to support users at each stage. The blue field may also contain links to useful documents, such as QCAA moderation advice.

Pop up reminders

There are pop up reminders about:

saving work

Pop up reminders

the status of your plan

Pop up reminders

the consequences of copying an assessment task

Pop up reminders

deleting work

Pop up reminders

and leaving the app.

Some of the pop ups require you to respond before continuing — others are timely reminders that support your progress.

Yellow warning messages

Validation is a compulsory step to support teachers to ensure they have completed all mandated fields. Yellow warning messages provide an opportunity for teachers to consider aspects of planning.

On screen, you can see a plan that is valid even though it has a warning message.

If you have not selected all content descriptions and all aspects of the achievement standard, you will be presented with a warning to consider.

Yellow warning messages

You may click the Summaries tab to view the coverage of the achievement standard and content descriptions. This will allow you to consider how much of the achievement standard and content descriptions you intended to select.

Yellow warning messages

If you have selected no General Capabilities, Cross Curriculum Priorities and /or focus areas, you will be presented with a warning to consider.

Warnings may be ignored. By closing the warning text field, you may proceed without taking any action.

When completing assessment task templates there is a similar validation process.

Red error messages

Red error messages must be actioned in order to proceed.

You may still close the warnings using the close button. However, you will not be able to validate your plan until you have completed each mandatory field in the plan.

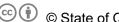
Red error messages

Any mandatory fields with a red asterisk that have not been completed will trigger a red error message. Mandatory fields contain information required for the app to maintain links between related documents and to support the generation of data summaries, such as school plans and assessment calendars.
