Unit	Unit 3: Marine systems — connections and change
Topic/s	Topic 1: The reef and beyond Topic 2: Changes on the reef

Other	Students use a practical or simulation performed in class as the basis for their methodology and research question.

## Context

You have completed the following practicals in class:

- examine coral diversity using a transect technique (using online or field data)
- investigate the effects an altered ocean pH has on marine carbonate structures.

## Task

Modify (i.e. refine, extend or redirect) an experiment relevant to Unit 3 subject matter to address your own related hypothesis or question.

You may use a practical performed in class, a related simulation or another practical related to Unit 3 (as negotiated with your teacher) as the basis for your methodology and research question.

#### To complete this task, you must:

- identify an experiment to modify
- develop a research question to be investigated
- research relevant background scientific information to inform the modification of the research question and methodology
- · conduct a risk assessment and account for risks in the methodology
- conduct the experiment
- collect relevant qualitative data and/or quantitative data to address the research question
- process and present the data appropriately
- analyse the evidence to identify trends, patterns or relationships
- analyse the evidence to identify uncertainty and limitations
- interpret the evidence to draw conclusion/s to the research question
- · evaluate the reliability and validity of the experimental process
- suggest possible improvements and/or extensions to the experiment
- communicate findings in an appropriate scientific genre, e.g. report, poster presentation, journal article, conference presentation.

#### You may collaborate with other students when:

- identifying an experiment
- developing a research question
- conducting a risk assessment
- conducting the experiment
- collecting data.

## Scaffolding

The response must be presented using an appropriate scientific genre (i.e. scientific report) that contains:

- a research question
- a rationale for the experiment
- reference to the initial experiment and identification and justification of modifications to the methodology
- raw and processed qualitative data and/or quantitative data
- analysis of the evidence
- conclusion/s based on the interpretation of the evidence
- an evaluation of the methodology and suggestions of improvements and extensions to the experiment
- a reference list.

## Example of how a practical could be modified to develop a research question

**Practical that will be modified:** Examine coral diversity using a transect technique (using online or field data).

**Research question:** Does the amount (percentage cover) of living coral in a [named] reef increase with distance (10 km and 50 km) away from the coast?

#### Developing the research question

Steps	Details
Identify the independent variable to be investigated.	Distance in km (of reef from coast)
Identify the dependent variable.	Amount of algae/dead coral (percentage cover)
Identify the methodology to be used.	Transect technique, using a coral health chart, e.g. from CoralWatch:

Draft research questions.	Does coral diversity change with distance from shore?
Refine and focus the research question.	Does the amount of dead coral to live coral increase with distance from the coast?
Present research question to teacher for approval.	Does the amount (percentage cover) of living coral in a [named] reef increase with distance (10 km and 50 km) away from the coast?

Note: You cannot use this sample research question for your experiment.

<ul> <li>inappropriate or irrelevant conclusion/s</li> <li>cursory or simplistic statements about the reliability and validity of the experimental process</li> <li>ineffective or irrelevant suggestions.</li> </ul>	1
