State review panel comparability meetings 2015

Purpose

To inform schools and state review panel members about the comparability meetings to be held in November 2015.

Background

Comparability is the process by which state review panels look for evidence that standards-based judgments about student achievement are comparable across districts in the state. State review panels look at sample folios for all Authority subjects across all levels of achievement from each district to ensure that the standards are being implemented consistently.

Information

Attached is a schedule of dates and the venue addresses for the one-day and two-day comparability meetings of state review panels. The meetings will be held over the period 9–12 November 2015, and each will start at 9:00 am.

State review panels will meet for either one or two days to consider:

- school submissions forwarded from district review panels for sampling
- unresolved submissions forwarded from district review panels for further review (where agreement has not been reached after consultation between the school and the district panels).

Meeting venues

The meetings will be held at the Brisbane International Virginia, corner Sandgate and Zillmere Roads, Boondall and at QCAA Head Office, Level 7, 154 Melbourne Street, South Brisbane.

Travel arrangements

The QCAA will arrange air travel, car hire and accommodation if the panellist qualifies.

Accommodation

For panellists approved for accommodation, rooms will be booked at the Brisbane International Virginia for those attending meetings there. For panellists attending meetings at QCAA Head Office, accommodation will be booked closer to the venue. Please note that following a QCAA travel policy review, all accommodation bookings will be made for a single room (if available).

Meals

Panellists requiring accommodation are provided with breakfast and dinner. Lunch for all panellists is provided at the meeting venue.

Use of own vehicle

A panel member may use their own vehicle, at their own risk. They do not need to produce evidence of motor vehicle insurance. If a panellist is using their own vehicle:

- and they **are** claiming the motor vehicle allowance, they need to seek pre-approval by filling out 'Use of own vehicle' on the *Comparability travel booking form*
- but they are **not** claiming the motor vehicle allowance, they do **not** need to fill out 'Use of own vehicle' on the *Comparability travel booking form*.

The QCAA will only pay a motor vehicle allowance when:

- the arrangement of a hire car or public transport is impractical due to the remoteness of the location, physical disabilities, etc.
- the Comparability travel booking form is completed and approved.

If a person is initially approved to travel by means other than their private motor vehicle (e.g. plane, hire car), but prefers, and is subsequently approved, to travel by their private motor vehicle, the total allowance paid must not exceed the cost that would have been incurred through the approved means of travel.

Panellists must be travelling more than 50 km to make a travel allowance claim. The claim rate is 37.5 cents per kilometre for the total return distance, i.e. a minimum claim of \$18.75.

A hire car should be used for road travel beyond 150 km.

A claim will not be paid if prior authorisation has not been obtained.

Taxis

Panellists using taxis to and from airports are required to include receipts with their claim form.

Parking

Free parking is available at Brisbane International Virginia.

For panellists attending meetings at QCAA Head Office, the use of public transport is encouraged. Limited parking is available on the street or at the Convention Centre car park on the corner of Merivale and Melbourne Streets, South Bank. The QCAA will meet the cost of parking. A travel claim, with the receipt attached, may be made after the meetings.

What you need to do

Principals are asked to bring this memo to the attention of staff who are members and chairs of state review panels.

State review panel chairs and members should note the dates of the comparability meetings and complete the *Comparability travel booking form* (including 'Use of own vehicle') if required.

Ensure forms are received by the QCAA no later than **14 September 2015** and preferably by email.
