## State review panel comparability meetings 2017

## **Purpose**

To inform schools and members of state review panels about November 2017 comparability meetings.

## **Background**

Comparability is the process by which state review panels look for evidence that standards-based judgments about student achievement are comparable across districts in the state.

State review panels look at sample folios for all Authority subjects across all levels of achievement from each district to ensure that the standards are being implemented consistently.

#### Information

Attached is a schedule for the one-day and two-day comparability meetings of state review panels.

The meetings will be held during the period from Monday 6 until Thursday 9 November 2017, and each meeting will start at 9:00 am.

State review panels will meet to consider:

- school submissions forwarded from district review panels for sampling
- unresolved submissions forwarded from district review panels for further review (where agreement has not been reached after consultation between the school and the district panels).

#### **Travel arrangements**

The QCAA will arrange air travel, car hire and accommodation if the panellist qualifies.



Panellists who qualify for travel arrangements will need to complete the *Travel booking form* available at <a href="https://www.qcaa.qld.edu.au/senior/moderation-hub/forms">www.qcaa.qld.edu.au/senior/moderation-hub/forms</a> (including 'Use of own vehicle', if applicable) and return it to the QCAA by **15 September 2017**, by:

#### Accommodation

For panellists approved for accommodation, rooms will be booked at the Brisbane International Virginia.

#### Meals

Panellists requiring accommodation will be provided with breakfast and dinner. Lunch for all panellists will be provided at the meeting venue.

#### Use of own vehicle

A panel member may use their own vehicle, at their own risk. They do not need to produce evidence of motor vehicle insurance. If a panellist is using their own vehicle:

- and they are claiming the motor vehicle allowance, they need to seek pre-approval by filling out 'Use of own vehicle' on the *Travel booking form*
- but they are **not** claiming the motor vehicle allowance, they do **not** need to fill out 'Use of own vehicle' on the *Travel booking form*.

The QCAA will only pay a motor vehicle allowance when the:

- arrangement of a hire car or public transport is impractical due to the remoteness of the location, physical disabilities, etc.
- Travel booking form is completed and approved.

If a person is initially approved to travel by means other than their private motor vehicle (e.g. plane, hire car), but prefers, and is subsequently approved, to travel by their private motor vehicle, the total allowance paid must not exceed the cost that would have been incurred through the approved means of travel.

Panellists must be travelling more than 50 km to make a travel allowance claim. The claim rate is 37.5 cents per kilometre for the total return distance, i.e. a minimum claim of \$18.75.

A hire car should be used for road travel beyond 150 km.

A claim will **not** be paid if prior authorisation has not been obtained.

#### **Taxis**

Panellists using taxis to and from airports are required to include receipts with their claim form.

#### **Parking**

Free parking is available at Brisbane International Virginia.

## What you need to do

Principals are asked to bring this memo to the attention of staff who are members and chairs of state review panels.

State review panel chairs and members should note the dates of the comparability meetings and complete the *Travel booking form* (including 'Use of own vehicle') if required. Ensure forms are received by the QCAA no later than **Friday 15 September 2017** and preferably by email.
